## Executive Summary

The 39th session of the Economic Commission for Latin America and the Caribbean (ECLAC), held in Buenos Aires from 24-26 October 2022, convened representatives from 32 member states, UN agencies, and intergovernmental organizations. The session focused on transformative recovery amid cascading crises, emphasizing the need for a new development model centered on production, inclusion, and sustainability. Key themes included addressing inequality, promoting employment, sustainable investment, digital transformation, climate action, and strengthening regional cooperation and multilateralism. High-level panels discussed globalization changes, employment creation, sectoral investment, and international cooperation. The session adopted resolutions supporting integrated development approaches, gender equality, social development, digital inclusion, and regional planning. ECLAC reaffirmed its role as a center of excellence for policy analysis and technical cooperation, aligning its 2024 work program with the 2030 Agenda and sustainable development goals. The meeting underscored the urgency of bold policies, innovative financing, and strengthened governance to overcome the region's challenges and foster inclusive, sustainable growth.

**Application 20:**

Promotion of comprehensive public policies and programs integrating sustainable development with a transformative gender perspective to respond to COVID-19 and other crises, including fostering comprehensive care systems and decent work for women.

**Application 21:**

Strengthening of regional statistical capacity, including support for the 2020 round of population and housing censuses and promotion of data sharing for SDG monitoring.

**Application 22:**

Support for the implementation of the Montevideo Consensus on Population and Development and related regional conferences and platforms.

**Application 23:**

Promotion of innovative financing mechanisms and strengthening of regional financial institutions such as the Development Bank of Latin America (CAF) and the Latin American Reserve Fund (LARF).

#### **Application 24:**

Encouragement of regional economic integration, including through MERCOSUR and other regional trade agreements.
