The focus was on electing the first members of the Committee to Support Implementation and Compliance. The event emphasized transparency, public participation, and environmental justice, reaffirming the region's leadership in environmental democracy. It culminated in the Buenos Aires Declaration and a renewed commitment to the agreement's principles and accountability mechanisms

Enhance coordination through ECLAC and regional mechanisms, enabling peer learning, monitoring, and legal innovation across the LAC region.
