## Executive Summary

The III Ibero-American Cooperation Quadrennial Action Plan (PACCI) 2023-2026, approved at the XXVIII Ibero-American Summit, sets a comprehensive framework to advance sustainable development and the 2030 Agenda across 22 member countries. Building on lessons from previous

cycles, the plan introduces eight strategic axes: strengthening cooperation systems, social cohesion, knowledge, gender equality, culture, environment, justice and public innovation, and sustainable productive transformation. It emphasizes cross-cutting approaches such as bilingualism, gender, non-discrimination, environmental sustainability, and enhanced visibility. The PACCI prioritizes inclusive policies for vulnerable groups, health, digitalization, environmental action, and gender mainstreaming. Governance improvements, robust monitoring, and evaluation mechanisms are established to ensure alignment, accountability, and measurable progress. The plan fosters multi-level, multi-stakeholder partnerships, aiming to consolidate Ibero-American Cooperation as a regional benchmark for achieving the Sustainable Development Goals.

Justification: Digital transformation is a major strategic axis and cross-cutting theme in the document. Justification: Multilateralism and regional/international cooperation are the core of the document, which is the Quadrennial Action Plan for Ibero-American Cooperation. The entire plan is structured around strengthening cooperation among the 22 Ibero-American countries, aligning with the UN 2030 Agenda, and leveraging multilateral mechanisms (PIPAs, sectoral networks, organizations) to address shared challenges. The governance, mission, vision, and most strategic axes are built on this foundation, making it the most central and extensively covered theme.

Justification: The Ibero-American General Secretariat (SEGIB) is the central coordinating body for the entire Quadrennial Action Plan. SEGIB leads or supports nearly all key initiatives, manages relationships among stakeholders, and is responsible for the implementation and visibility of the plan. Its influence is foundational to the governance and execution of the PACCI.

Justification: The 22 Ibero-American governments are the primary decision-makers, owners, and implementers of the Action Plan. They set priorities, approve the PACCI, lead the sectoral spaces, and are responsible for the execution of policies and programs. ### **Application 5:**

Ongoing training and technical assistance sessions for Ibero-American countries on the use of SIDICSS and results-based management, delivered by SEGIB and PIFCSS.

### **Application 6:**

Active partnerships and joint projects with the European Union, including the “Generation of knowledge and new instruments in EU-LAC Triangular Cooperation” project under the Adelante Program, with a 30-month grant contract signed in December 2021.

### **Application 7:**

Strengthening of the Strategic Management Committee of Ibero-American Organizations (CODEI), which coordinates the work of OEI, OISS, OIJ, and COMJIB, to align sectoral actions and promote joint planning and transparency.

### **Application 8:**

Operation of the Registry of Ibero-American Networks, which registers and supports networks working in prioritized cooperation areas, and provides capacity-building and knowledge-sharing activities.

### **Application 9:**

Implementation of the Ibero-American Action Plan for the Implementation of the Rights of Indigenous Peoples, including support for the International Decade of Indigenous Languages

2022-2032.

### **Application 10:**

Consolidation and regular convening of the Ibero-American Forum on Migration and Development, with four editions held (Ecuador 2008, El Salvador 2010, Guatemala 2018, Portugal 2023) to promote dialogue and best practices on migration.

### **Application 11:**

Launch and development of the Ibero-American Epidemiological Observatory (OEPI), a multi-stakeholder platform for health data, research, and response, as mandated by the XXVII Ibero-American Summit.

### **Application 12:**

Implementation of the Ibero-American Framework for Academic Mobility – Campus Iberoamérica, including a digital platform and a growing network of associated institutions and programs.

### **Application 13:**

Operation of the Ibero-American System for Quality Assurance in Higher Education (SIACES), including the Ibero-American Registry of Accredited Programs and the Ibero-American Quality Seal of Virtual Teaching.

### **Application 14:**

Implementation of the Ibero-American Innovation Strategy (EII), with the establishment of a Technical Committee and Advisory Committee, and the design of five innovation missions (food, climate change/environment, digitalization/AI, health, energy transition).

### **Application 15:**

Implementation of the Ibero-American Strategy for the Digital Transformation of Higher Education (EITDES), including biennial plans and the development of a digital quality seal.

### **Application 16:**

Execution of the Ibero-American Strategy for Culture and Sustainable Development (EICDS), aligning cultural policies with the 2030 Agenda and supporting 12 cultural cooperation programs and one initiative.

### **Application 17:**

Promotion of the Strategic Plan for Ibero-American Cultural and Creative Industries, supporting capacity-building and digital platforms for the sector.

### **Application 18:**

Convening of the Conference of Ibero-American Water Directors (CODIA) and strengthening of its initiatives on integrated water resources and disaster risk management.

### **Application 19:**

Promotion of the Ibero-American Environmental Charter, approved at the XXVIII Ibero-American Summit, consolidating regional commitments on climate and environment.

### **Application 20:**

Support for the Voluntary Coalition for the Progressive Closure of Dumpsites and other technical networks addressing pollution, waste management, and marine debris.

### **Application 21:**

Regular organization of the Ibero-American Public Innovation Week and support for Civic Innovation Labs and the CIVICS mapping tool for civic innovation initiatives.

### **Application 22:**

Biennial Operating Plans (POBs) for 2023-2024 and 2025-2026, detailing activities, budgets, responsible areas, and indicators for PACCI implementation, approved by the Heads of Cooperation.

### **Application 23:**

Annual follow-up reports on PACCI implementation, prepared by SEGIB and submitted to the Heads of Cooperation.

### **Application 24:**

Implementation of the Strategic Plan for the Visibility of Ibero-American Cooperation (PEVCI), including the Somos Iberoamérica portal, Ibero-American Cooperation Week, and the Network of Communication Focal Points.

### **Application 25:**

External mid-term and final evaluations of PACCI, with lessons learned used for future planning and accountability.
