## Executive Summary

The VIII Summit of Heads of State and Government of CELAC, held in Kingstown on March 1, 2024, reaffirmed the region's commitment to peace, democracy, human rights, and multilateralism. Key focuses included economic stability, food security, social cohesion, and sustainable development, emphasizing the eradication of poverty and inequalities. The Summit condemned unilateral sanctions and called for fair international financial systems and enhanced cooperation with global organizations. It highlighted regional integration projects, sustainable energy transition, digital inclusion, and scientific collaboration. Climate change mitigation, biodiversity conservation, disaster risk management, and ocean protection were prioritized, alongside support for vulnerable groups such as indigenous peoples, Afro-descendants, women, youth, and persons with disabilities. The Summit also addressed peace and security, including support for Haiti and Colombia peace processes, nuclear disarmament, and opposition to blockades against Cuba. It endorsed reparatory justice for historical injustices and strengthened South-South and extra-regional cooperation, notably with the EU, China, and Africa. The Summit welcomed Honduras as the incoming Pro Tempore Presidency.
